TO ALL POTENTIAL FOOD VENDORS:

Thank you for interest in being a food vendor at the 2010 Northern Lights Bluegrass and Old-Tyme Music Festival. This year's festival is being held August 20 to 22, 2010 and is held at a remote location 20 km NE of Big River, Saskatchewan.

The following are the guidelines for Food Vendors for the 2010 Festival:

Preference will be given to vendors who:

- 1) have liability insurance
- 2) are self-contained (minimum or no need for cold storage and/or power)
- 3) are community-based organizations
- 4) create minimal garbage
- 5) offer healthy, unique food choices
- 6) provide biodegradable cups and plates

Electrical Requirements:

Because the electrical capacity of the Ness Creek Site is limited, the following requirements have been developed to minimize consumption as well as addressing safety and equal use of power.

- 1) Each vendor is supplied with two 15 amp 120 volt plugs
- 2) All electrical equipment (including cords) should be in good condition, safe and complete with a ground wire.
- 3) Electrical cooking and heating appliances are not allowed because of their power draw.
- 4) Refrigerators and freezers should only be large enough to handle your festival needs.
- 5) Vendors are encouraged to conserve power whenever possible. This can include designing menus which require less power to prepare and serve, and also using insulated carafes to hold hot beverages, soups and sauces before serving.
- 6) If Vendors require their campers and trailers to be plugged in they must use only the two plugs provided.
- 7) Vendors should be prepared with a generator in the event of a power outage.

The Northern Lights Bluegrass and Old-Tyme Music Festival may provide \$7 food vouchers for our performers. Food vendors are required to honour these vouchers, which Northern Lights will redeem at the end of the Festival. Please give us examples of what you could provide in exchange for a \$7 fee.

We are also trying to prevent duplication. We don't want everybody to be selling burgers, fries and hotdogs. Would you be interested in selling only certain foods to avoid duplication? Please address our preferences in your application.

If you have not operated a Food Booth at Northern Lights before please provide a list of your experience and references.
